- Does not engage in contraceptive counseling or referral for contraceptives or contraceptive services.
- Recognizes the validity of adoption as one alternative to abortion and is not biased toward adoption when compared to other life-saving alternatives.
- Does not initiate nor facilitate independent adoptions; nor receives payment of any kind from adoption agencies; nor enters into a contractual relationship with adoption agencies; nor share office space.
- Advertising and communications will be truthful and honest and accurately describe the services we offer.
- Staff and volunteers receive proper training to uphold these principles.
- Services are personal, confidential, and non-judgmental.
- Offers assistance at no charge.
